

Privacy and security policy

The here presented privacy notice is made by Dante in line and are intended to comply with the provisions of privacy to our customers and students.

By providing personal data or sensitive personal data to Dante in linea, through the page of internet or directly by phone call, either to ask for information, register for a course of Italian, request application of CILS /DITALS certification exams or any other purpose through which it is necessary to collect your personal information, you agree to the treatment of your personal data or sensitive personal data in the manner described in the This privacy notice.

Otherwise, you are encouraged to not use the page of internet and not to provide personal data or sensitive personal data to Dante in linea by any means and for any purpose.

INFORMATION WE COLLECT

Registration Information. You are not required to register or give us any personal information about yourself in order to visit the Website and or to view certain features made generally available on our Website. However, we may offer you the opportunity to register with us or to sign up for our mailing list. Although registration is not required to visit our Website, in order to access our premium features available on our Website, and in order to use certain other services that may be offered on our Website, you will be required to register and create an account with Dante in Linea ("Dante in Linea Account"). When you create your Dante in Linea Account, you will be required to provide certain personal information from you, including your first and last name, a user name (which will be your email address), the country in which you reside, your phone number and a password. At other times, you may also be asked to provide us with additional information, such as your age, gender, and other personal information about yourself in order to receive additional information about our services.

In addition, prior to using the Service, you may also be required to provide information of your credit card or other payment instrument and your billing address. If you authorize us to do so, we will retain your credit card information in our database to facilitate your checkout process for future transactions, all in accordance with regulations issued by credit cards networks.

As part of the process to create an Dante in Linea Account or to participate in certain promotions offered by Dante in Linea such as entering sweepstakes, contests, surveys, newsletters, etc., in addition to name, email and address, you may be asked to provide certain information which, by itself, does not personally identify you. For example, you may be asked to provide information concerning your education or preferences, purchasing habits, and the like. When you use a mobile device like a tablet or phone to access our Service, we may access, collect, monitor, store on your device, and/or remotely store one or more "device identifiers." Once you have registered with us, we also track and collect information about you, including your transactions with us, our affiliates, or others, and your site usage patterns, such as the pages on the Website you have visited, searches you have conducted and the amount of time you have spent on our Website. If you contact us, we may keep a record of your correspondence.

Testimonials. Dante in Linea may post customers' testimonials on our Website, which may contain personal information from our customers. Once you accept the Terms of Service applicable to the Service, you give your consent to Dante in Linea to publish any testimonial, post, comments, name and any other representations.

Information We Receive From Our Affiliates. You may also separately provide information about yourself to third party or co-branded sites through which we provide access to our service ("Affiliate Sites"). When you register with us, the Affiliate Site that you came from may provide us with your user/member name and password from such site. Some of those Affiliate Sites or other sites may share other information that you provide to them with us. By using our services, you agree to allow us to receive and use any information, except for credit card information that you may provide to such Affiliate Sites or other sites, under the same terms as if you provided it to us directly. Whether or not that Affiliate Site or other site actually shares your information and to what extent they do share with us will depend on their agreement with us and their individual privacy policy.

COOKIES

Cookies are small text files that a web server sends to your computer, recalling the activity that you previously held. Temporary cookies are used for the navigation of the web site, to identify the beginning of session and these placed in a user's hard drive in order to visit or register on the website, but after a short time they will expire automatically.

Most browsers allow you to disable or enable the use of cookies. You can also delete cookies from your computer if your browser allows it. If you disable the cookies, it is possible that you cannot use certain parts of our services and you may need to reinstall the cookie rejection.

The personal data or sensitive personal data that we collect with these technologies in your case are the ones that are mentioned in the section on "Data personal and/or data personal sensitive subject to treatment" of this same privacy notice.

WHAT WE DO WITH YOUR INFORMATION

In general, Dante in Linea may use information about you to provide and improve its Service. Dante in Linea may share this information with the suppliers of content on the service, affiliates and other entities in non-personal form to show general demographic and preference information among users of the Service or for other purposes. This information may include usage and demographic data, but it will not include personal information (such as your email address).

As part of the Service, Dante in Linea may provide you feedback regarding your progress in the form of video messages hosted on third party websites, which messages can be viewed by other users of such third party websites. Although these video messages will not identify you by name or photograph, if you do not wish to receive such feedback, you will have the ability to opt-out of receiving and having such messages hosted on the third party websites.

The resulting buyer, surviving company or transferee will honor the commitments we have made in this Privacy Policy. We do not share your credit card account information with Affiliate Sites or any other third parties, other than order processing and credit card clearance service providers as described below.

In order to keep you informed about our services, we may send e-mails and announcements that are needed for the administration of our Website and Service. We also may provide our users with the option of joining our mailing list to receive additional information about our Website, services and offers, including the services and offers of Dante in Linea INC or its affiliates.

Additionally, we may, from time-to-time, allow you to choose whether you would like to receive mailings from third parties with whom we have affiliate relationships. You will always have the ability to change your options by accessing your Dante in Linea Account. Each marketing e-mail from Dante in Linea will include instructions for how to unsubscribe from our mailing list.

We work with third parties who provide services, which may include website hosting, promotion fulfillment, order processing, credit card clearance, data analysis and other services of an administrative nature. Personal information, including financial information, may be shared with such third parties for the purpose of providing such services to you. We seek to impose confidentiality obligations on such service providers. Also, Dante in Linea INC, which owns Dante in Linea, will be able to use your personal information under the terms of this Privacy Policy. We also reserve the right to disclose personal information to third parties when we believe in good faith that the law requires it, to enforce our Terms of Service, to protect the rights, property,

safety, or security of Dante in Linea or the public, to respond to an emergency, or as otherwise stated in this Privacy Policy.

Following termination or deactivation of your account, Dante in Linea, its Affiliates, or its Service Providers may retain information associated with your profile information for a commercially reasonable time for backup, archival, and/or audit purposes.

SECURITY

We use reasonable security methods to protect the data that resides on our servers. However, because no security system is impenetrable, we cannot guarantee the security of our servers. It is also possible that information you supply to us will be intercepted during transmission.

Whenever you give Dante in Linea sensitive information (e.g., credit card numbers), Dante in Linea will take commercially reasonable steps to protect such information by establishing a secure connection with your Web browser. Dante in Linea employs an industry standard technology known as a secure-socket-layer ("SSL") to protect the transmission of payment information to the Website. You can check the security of your connection by looking at the address in your browser window. After you have accessed a secure server protected by SSL, the first characters of the address will change from "http" to "https."

Please do your part to help us. To help protect your Dante in Linea Account information, please keep your password secure. Dante in Linea will generate a link to create a new password in case you forget it and send it to the email account you provided. This will not affect your settings in any way. Ultimately, you are responsible for maintaining the secrecy of your passwords and any Dante in Linea Account information.
